ORDINANCE NO. 2017-11

AN ORDINANCE TO APPROVE REPAYMENT OF A LOAN FROM THE OHIO PUBLIC WORKS COMMISSION FOR THE HARTFORD AVENUE WATERLINE PROJECT CQ19Q/CQ20Q AND TO DECLARE AN EMERGENCY

WHEREAS, Council approved the Hartford Avenue Waterline Project CQ19Q/CQ20Q ("Hartford Project") as provided in Ordinance Nos. 2013-10 and 2013-11; and

WHEREAS, the Village as part of the Hartford Project received grant funds from the Ohio Public Works Commission;

WHEREAS, the grant funds received from the Ohio Public Works Commission ("OPWC"), which OPWC funds were not permitted to exceed more than 90% of the Hartford Project costs pursuant to Ohio law;

WHEREAS, the total costs of the Hartford Protect were \$215,289, with OPWC paying \$204,524.54 (or 95%) and the Village contributing \$10,764.46 (or 5%);

WHEREAS, the Village has received a request from OPWC for payment of an additional \$10,226.23, which is 5% of the total amount paid by OPWC of \$204,524.54 to comply with Ohio law and can be repaid in the form of a loan payments of \$255.66/bi-annually;

WHEREAS, the Village Engineer, Village Clerk and Village Solicitor has reviewed the request and deem it reasonable and in conformance with Ohio law;

NOW, THEREFORE, be it ordained by the Council of the Village of Centerburg, Ohio as follows:

Section 1: That the Clerk Treasurer is hereby authorized to repay OPWC the full amount of \$10,226.23, by making the periodic OPWC loan payments for the Hartford Avenue Waterline Project CQ19Q/CQ20Q for a term of 20 years.

Section 2: That Council declares this to be an emergency measure, such emergency rising out of the need to accept make timely payments to OPWC in conformance with the loan repayment schedule.
