ORDINANCE NO. 2017- 09

AN ORDINANCE TO AUTHORIZE VILLAGE ADMINISTRATOR TO CONTRIBUTE AN AMOUNT NOT TO EXCEED \$3,000 TOWARDS THE COST OF REPAIRS TO A CERTAIN FOOTBRIDGE IN CENTERBURG COMMUNITY MEMORIAL PARK, AND DECLARING AN EMERGENCY.

WHEREAS, an unnamed footbridge exists across the North Fork Licking River adjacent to the Centerburg Community Memorial Park, with the north end of the bridge in the Park on land owned by Hilliar Township, and the south end of the bridge on land owned by the Village of Centerburg and adjacent to Main Street; and

WHEREAS, the footbridge needs substantial structural repairs and reinforcement to ensure the safe passage of pedestrians leaving the Village sidewalks and rights of way while seeking to enter Memorial Park, which repairs are mentioned in more detail in Exhibit "A" attached hereto; and


WHEREAS, the repairs are immediately necessary to preserve the health, safety, and welfare of the public who are expected to access Memorial Park over this footbridge during the traditional summer months of intense and park usage; and

WHEREAS, Hilliar Township and other entities affiliated with operating and managing Memorial Park, have requested that the Village contribute \$2,702.39 towards the total expected cost of \$7,929.00.

NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE VILLAGE OF CENTERBURG, OHIO:

- Section 1. That the Village Administrator and/or the Clerk/Treasurer are hereby authorized to disburse \$2,702.39 to Hilliar Township, or to an appropriately-designated park-affiliated entity for the Centerburg Community Memorial Park footbridge repairs identified in the document attached hereto as Exhibit "A."
- Section 2. That upon request of Hilliar Township or an appropriately-designated park-affiliated entity, and upon approval of the Village Administrator, the Clerk/Treasurer is further authorized to distribute an additional amount of \$297.61 for the Memorial Park footbridge repairs.
- Section 2. That this ordinance is hereby declared to be an emergency measure necessary for the preservation of the public peace, health, safety and welfare, such emergency arising out of the need to repair failing structural components of a footbridge that is most frequently used in the summer months by members of the public to access Memorial Park.

WHEREFORE, this ordinance shall take effect immediately upon passage and approval by the Mayor.


