

ORDINANCE NO. 2020- 01

**TO AMEND ORDINANCE 2019-15 AND REVISE QUALIFICATIONS OF
THE FISCAL OFFICER OF THE VILLAGE OF CENTERBURG AND TO
DECLARE AN EMERGENCY.**

WHEREAS, Section 733.262 subsection (D) of the Ohio Revised Code provides “*the fiscal officer shall become a resident of the village within six months after the appointment takes effect, unless an ordinance is passed approving the fiscal officer's residence outside of the village*”; and

WHEREAS, the Fiscal Officer is not an employee whose immediate presence is required in an on-call capacity; and

WHEREAS, The Village of Centerburg does not wish to cause a hardship for its new Fiscal Officer; and

WHEREAS, Council has reviewed a wage, salary and benefits for the new Fiscal Officer, Shawna Humes, who has agreed to accept the position of Fiscal Officer,

**NOW THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE VILLAGE
OF CENTERBURG, STATE OF OHIO, THAT:**

Section 1. The Fiscal Officer, Shawna Humes, upon hire will be paid a salary of \$42,000.00 per year, payable bi-weekly beginning the Fiscal Officer's first day of employment.

Section 2. The Village agrees to Council hereby approves the Fiscal Officer, Shawna Humes, residing outside the Village limits as contemplated in ORC 733.62.

Section 3. To amend Ordinance 2019-15 Section 3 to read “The Qualifications for this position shall be at least a ~~Bachelors'~~ an Associate's Degree in accounting finance, public administration, business, and/or a related degree within the above disciplines. Additionally, the appointee should have public finance experience and/or experience commensurate with the proposed position.

Section 4. The Village agrees to honor Shawna Humes' years of service as an Ohio Public Employee Retirement System employee with respect to Village vacation and other personnel benefits.

Section 5. The Village agrees to accept transfer of 80 hours of sick leave to Shawna Humes' sick leave account with the Village.

Section 6. This Ordinance is determined to be an emergency, necessary for the immediate preservation of the public peace, health and safety, such emergency arising out of the necessity to provide a fair wage for the newly hired Fiscal Officer upon her first day of employment.

WHEREFORE, this Ordinance shall take effect and be in force from and after its passage and approval by the mayor on the earliest date allowed by law.
