ORDINANCE 2017-05

TO AMEND ORDINANCE 2016-01 AND 2016-19 TO COMBINE THE POSITIONS OF VILLAGE ADMINISTRATOR AND UTILITY SUPERINTENDENT AND TO APPOINT M. JOSEPH HARDIN TO THIS POSITION, AND TO APPOINT A ZONING INSPECTOR AND TO DECLARE AN EMERGENCY

WHEREAS, Council has a vacancy in the position of Village Administrator; and

WHEREAS, Council has determined that the current Utility Superintendent should be appointed to the vacant Village Administrator position, but also retain some of the duties of the Utilities Superintendent position;

WHEREAS, Council has determined that the former Village Administrator should be appointed to the position of Zoning Inspector as part of the allocation of the duties of the Village Administrator position;

NOW THEREFORE, be it ordained by the Council of the Village of Centerburg as follows:

Section 1: That Section 1.F and Section 1.J of Ordinance 2016-19 and Section 1 of Ordinance 2016-01 shall be amended, in part, with respect the provisions regarding the Village Administrator and Utilities Superintendent's compensation and duties to provide as follows:

Section 1.F. That M. Joseph Hardin, effective April 1, 2017, is promoted from the position of Utilities Superintendent to the combined positions of Village Administrator and Utilities Superintendent and shall be compensated based on an annual salary of \$82,000 per year, provided however, this amendment to Ordinance shall be deemed temporary so that Council can evaluate the impact on Village services, and thus, this amendment shall, expire effective October 15, 2017, unless extended by Council, and upon expiration, the provisions of Ordinances 2016-01 and 2016-19 amended hereby shall again become effective.

Section 2. That Ordinance 2016-19 shall be amended to include Section 1.N providing as follows:

<u>Section 1.N</u>. That Phil Lohmeyer shall be appointed to the position of Zoning Inspector effective April 1, 2017 and shall be compensated at an hourly rate of \$12.00 per hour, provided however, the Zoning Inspector's annual compensation shall not exceed \$5,000.

That all other provisions of Ordinances 2016-01 and 2016-19 shall remain Section 3. unchanged.

That this Ordinance is declared an emergency measure necessary for the Section 4. immediate preservation of the public peace, health, safety and welfare, such emergency arising from the need to fill the duties of Village Administrator and zoning inspector and provide fair compensation to the employees so appointed.

WHEREFORE, this Ordinance shall take effect and be in force immediately from and after its passage and approval by the Mayor.
